CENTRAL AIR CONDITIONING LOAD MANAGEMENT AGREEMENT

This is an Agreement, made and entered into this ____ day of _____, 20____, by and between **Prairie Energy Cooperative** and _____ (Member), the terms of which are as follows:

1. (a) Allow Cooperative to verify that the Central Air Conditioner is on Prairie Energy's system identified by the Cooperative's records as location number _____:
(b) authorize Cooperative, at Cooperative's expense, to install, operate, maintain, and replace as necessary, **Load Management device on the Air Conditioner equipment** that will allow Cooperative to interrupt or cycle outdoor compressor unit for brief periods while the circulation fan continues to operate.
(c) Currently the Cooperative does not participate in this program but may require participation in the future.
2. Member agrees that neither the Cooperative nor its power supplier shall be liable for any loss, costs, or damages caused by or resulting from this Load Management Device.
3. The Cooperative shall have the right to cancel this Agreement in the event Member fails to install the Air Conditioner or tamper with or modifies the Air Conditioner or tampers with or modifies the Load Management device. Member may cancel this Agreement by giving Cooperative not less than thirty (30) days advance written notice of cancellation. In the event of cancellation by Cooperative or Member, Member shall allow the Cooperative to remove the load control equipment.
4. Amount of rebate to be paid for Members signing Agreement
 - (a) SEER 15+ = \$50.00 per unit
 - (b) SEER 16+ = \$100.00 per unit
